

Torii Station Outdoor Recreation Flea Market

In consideration for receiving permission to participate in Torii Station Flea Markets, sellers assume all risks and release the U.S. Government and its officers, employees, United States Army Garrison (USAG) Okinawa personnel and sponsors of said activity from liability for all claims for loss or damage to property and injury or death to persons arising from participation in the above said activity. Vendors accept all risks involved in the activity and must read and understand the Flea Market Rules. Failure to abide by any of the Flea Market Rules may lead to immediate expulsion from the flea market area as well as temporary or permanent disbarment from taking part in future flea market events at the discretion of the USAG Okinawa Garrison Commander.

HEALTH & SAFETY

- No pets may be brought to the Flea Market or be kept in vehicles during the sale.
- Alcoholic beverages are prohibited from being brought to or consumed at the sale.

RULES

1. The Flea Market **opens to sellers** at 11 a.m. for setup and **opens to the public** at noon for purchases.
2. The Flea Markets **ends** at 5 p.m. **Sellers must complete their final sales and are responsible for cleaning their designated areas before closing time.**
3. Anyone entering before opening time must be a seller with SOFA status and have a valid Department of Defense (DoD) identification card. The following are exceptions to this rule:
 - Visiting family members with valid passports who are accompanying sellers.
 - Local national family members with valid DoD ID cards who are accompanying sellers.
4. Payment of fees guarantees a designated selling area at the Flea Market on the scheduled day; it does NOT grant a pre-assigned/reserved selling area. Selling areas are designated on a first-come, first-served basis. Flea Market personnel will direct the parking.
5. The minimum number of sellers for the event is 15. Sellers will be provided a full refund if cancelled due to lack of sellers.
6. **Entrepreneurs/Commercial Vendors**— must register as a craft vendor with the Special Events Food & Craft Vendor POC.
7. Sellers are responsible for obtaining other desired supplies, e.g., tables, canopies, tarps, chairs, etc. Supplies, when available, may be rented from Outdoor Recreation for the duration of the Flea Market. Visit [Outdoor Recreation](#) for details.
8. Sales must be confined to the parking lot assigned for the flea market. Sellers are confined to sales and display of goods in the chosen selling area in the front and/or rear of the vehicle. There will be no sales or display of goods from the sides of vehicles. Selling goods outside the designated selling area is prohibited.
9. No advertising of businesses which have not been registered as a craft vendor.
10. **Items that cannot be sold:**
 - **New Items** Items that have never been used or worn, still in the original packing, still have tags, etc., may NOT be sold at the flea market unless the seller can provide proof, i.e., customs forms and receipts, showing that required taxes have been paid on the items to be sold.
 - **Food Items** No food items of any kind may be sold or given away. This includes Meals Ready to Eat (MREs), candy, spices, fresh fruits, vegetables, food purchased at DeCA, etc. Only DFMWR activities will be permitted to operate food concessions.
 - **Arts and Crafts Items** Arts and Crafts items constructed or manufactured in any DFMWR or any other MWR facility are prohibited.
 - **Explosives**
 - **Flammable Liquids or Gases** Items including, but not limited to, gasoline, Coleman fuel (butane, propane), Sterno cups, etc. may NOT be sold.
 - **Firearms and Weapons** Items including, but not limited to, BB guns, pellet guns, paintball guns, spear guns, bows, knives, etc. may NOT be sold.
 - **Ammunition** Items including, but not limited to, bullets, pellets, BBs, paintball pellets, arrows, etc. may NOT be sold.
 - **Pornographic Material**

- **Alcoholic Beverages**
- **Tobacco Products**
- **Live Animals or Pets** Exception: Only advertisements of pets given (free of charge) to good homes are allowed. Animals may not be brought to the sale.
- **Fake, Imitations of Copyrighted Items** Items including but not limited to, Louis Vuitton, Gucci, Coach, Rolex, Prada, etc. may NOT be sold.
- Pirated media on any digital storage device, video, cassette, DVD, computer disk, etc. may NOT be sold.

11. No new items sent through FPO/APO boxes may be sold, unless proof can be provided that the proper taxes have been paid.

CANCELLATION & NOTICE

Right to Cancel: The Outdoor Recreation reserves the right to cancel an event in cases of emergencies which include, but are not limited to, unsafe Health Protection Levels (HPCON), extreme weather conditions (e.g. violent typhoons, high winds, heavy downpour) and Commander-ordered changes in the installation Force Protection Condition (FPCON) that result in level "BRAVO" or higher.

Notification: In these cases, a decision to cancel an event will be made No Later Than 0800 HRS on the applicable event day resulting in restricted access to the Installation. Sellers will be notified in such cases as soon as this information is available. Refunds: Refunds will only be provided when Outdoor Recreation has reserved the right to cancel the event.

STATEMENT OF LIABILITY: I agree to release and hold harmless the USAG-Okinawa, Family and MWR, and the United States Government from any liabilities for injuries, damages, or losses incurred by me or my property, or caused by government negligence, while being present on, entering, and leaving the premises for the purpose of participating in the Flea Market. This release is binding on my heirs, executors, and assigns. In addition, I agree to indemnify the U.S. Government for any damages I cause while participating in said event.
