SUBJECT: School Year (SY) 2016/2017 Tuition Rates

The tuition rates per the attached charts apply to Federally and Non-Federally connected, Non-Department of Defense students attending DoDEA Pacific and DoDEA Europe schools during SY 2016/2017. It is DoDEA's policy, to collect payments in advance for a child who meets the enrollment criteria as a tuition paying student. Tuition is considered a debt to the Government; therefore failure to pay tuition in a timely manner can result in the inability to enroll dependents at the beginning of the SY or subsequent disenrollment during the SY. The published rates include a ***non-refundable*** Treasury Share Fee. The Treasury Share Fee and the tuition rates are computed using the full cost recovery methodology in compliance with Government Accountability Office (GAO) guidelines.

Beginning October 1, 2015, DoDEA transitioned to a new accounting system which requires sponsors to make (2) separate payments based on the number of instructional days of the Fiscal Year. The Fiscal Year begins October 1, 2016 and ends September 30, 2017. The separate payments are required to accurately collect and record tuition during the Fiscal Year in which the student attends school. It is critical that sponsors submit payment no later than the due date per your invoice. Invoices for Payment #1 will be mailed no later than July 31, 2016 and Invoices for Payment #2 will be mailed no later than August 31, 2016.

Payment #1: (Fiscal Year 2016): Aug 1, 2016 - Sep 30, 2016 **Due Date: NLT Aug 31, 2016**

Payment #2: (Fiscal Year 2017): Oct 1, 2016 - Jun 30, 2017 **Due Date: NLT Oct 1, 2016.**

To qualify for the posted DoDEA Virtual High School (DVHS) tuition rate, students ***must*** be dependents of ***active-duty service members***, have attended a DoDDS school or Non-DoD School Program (NDSP) prior to returning to the United States, and ***must*** be enrolled in a local stateside school. The purpose of this tuition schedule is to provide an opportunity for students who transfer from an overseas location to a local stateside school in the United States, to complete coursework that is not offered in the receiving school. Courses are only offered on a semester basis. All other instances will not qualify for this tuition rate.
