**MEMORADUM FOR DODEA DIRECTORS FOR STUDENT EXCELLENCE**

**SUBJECT:** OCONUS School Year (SY) 2025/2026 Tuition Rates (Europe, Pacific, and Cuba):

The tuition rates in the attached chart apply to Federally and Non-Federally Connected, Non-Department of Defense students attending DoDEA schools in Europe, the Pacific, and Cuba during School Year (SY) 2025/2026. **In accordance with DoDEA policy, payment is required within 30 days** from the date of the tuition invoice for any child determined to be a tuition-paying student. Tuition constitutes a debt owed to the U.S. Government. Accordingly, failure to remit payment in a timely manner may result in the denial of student enrollment at the beginning of the school year or disenrollment during the academic year.

Tuition charges include a non-refundable Treasury fee. Both the Treasury fee and tuition rates are calculated using a full cost recovery methodology in compliance with Government Accountability Office (GAO) guidance.

DoDEA tuition invoices for SY 2025/2026 will be issued in two separate billing packages:

- 1. First Payment** – Using FY 2025 funds, this payment covers part of the First School Quarter from August 2025 through September 30, 2025. **Payment is due within 30 days of the invoice date.**
- 2. Second Payment** – Using FY 2026 funds, this payment covers the remainder of the school year from October 1, 2025, through June 2026. **Payment is due within 30 days of the invoice date.**

**Refund Policy Reminder:** Pursuant to DoDEA Administrative Instruction 7200.01, Change 2, dated July 29, 2024, Section 4.2.a – *Grading Period Refund*, “Once a student has attended any portion of a grading period, a refund for the remaining portion of the grading period is not authorized.” Parents and sponsoring agencies are advised to plan accordingly, as prorated refunds are not permissible once a student has been in attendance during any part of a grading period.

To qualify for the published DoDEA Virtual High School (DVHS) tuition rate, the student must be a dependent of an active-duty service member, must have been enrolled in a DoDEA overseas school or a Non-DoD School Program (NDSP) prior to returning to the U.S., and must be concurrently enrolled in a local stateside school. This rate is only applicable for semester-based courses not offered by the receiving school. Other circumstances do not qualify for this tuition rate.
